**CALL FOR APPLICATION FOR POSTDOCTORAL SCHOLARSHIP OF THE
GRADUATE PROGRAM IN ANIMAL SCIENCE**

The Graduate Program in Animal Science (PPGCA) of the Federal Rural University of the Semi-arid Region (UFERSA), under its regimental duties, hereby announces the call for applications for postdoctoral scholarship, which shall be granted according to the norms herein.

1. REQUIREMENTS AND NUMBER OF SCHOLARSHIPS OFFERED

1.1 One (1) scholarship, in the amount of R\$ 4,100.00 monthly financial aid, according to CAPES scholarship reference table, will be granted by PNPD Capes Program to a postdoctoral researcher. It will be granted for a period of 12 (twelve) months, renewable for an equal period, at the discretion of the collegiate body of the program and in accordance with Ordinance No. 086/CAPES, of July 3, 2013.

1.2 These are the scholarship holder's attributions during the scholarship period:

- a) To teach at least one course per year in one of the PPGCA research lines;
- b) To participate in research groups and co-advise undergraduate and graduate students;
- c) To meet the PPGCA coordination needs for administrative support;
- d) To write at least 2 papers and submit them for publication in journals with Qualis Capes A1, A2, or B1 in the knowledge area of Veterinary Medicine;
- e) At the end of the 11th month of the scholarship period, the scholarship holder must present a report, with supporting documentation attached, for the PPGCA's collegiate body to appreciate and decide on renewal based on the scholarship holder's performance and the availability of the scholarship financial aid.

1.3 Minimum application requirement:

- a) When the scholarship is granted, the applicant must hold a doctorate degree in programs evaluated by CAPES and accredited by CNE (Brazilian National Education Council)/MEC (Ministry of Education). In case of Doctorate degree granted by a non-Brazilian institution, it must be analyzed by the PPGCA's collegiate body;

1.4 The applicant may apply in one of the following types:

- a) as a Brazilian or non-Brazilian applicant residing in Brazil, holding a temporary visa, and without employment relationship; or
- b) as a non-Brazilian applicant residing abroad and without employment relationship; or
- c) as a faculty or researcher with employment relationship with higher education institutions or public research institutions in Brazil.

§1º Non-Brazilian applicants residing abroad must prove home address abroad at

the time of the application submission;

§2º Regardless of temporary faculty's teaching activities, they may be approved in type "a" of item 1.4 after the appreciation and authorization by PPGCA.

§3º. Applicants approved in type "c" of item 1.4 must prove removal from the home institution activities for a minimum time compatible with the scholarship period.

§4º Applicants approved in type "c" of item 1.4 will not be able to carry out the postdoctoral internship at the same institution which they have employment relationship with.

1.5 Supervisor:

- a) The applicant's proposal must include an intended supervisor's name, who must be a PPGCA tenured faculty member whose researches fit to one of the Program's research lines (see ANNEX I);
- b) The supervisor must have completed at least two master's degree advising.

1.6 Monitoring and evaluation:

At the end of the 11th month of the scholarship period, the scholarship holder must present a report, with supporting documentation attached, for the PPGCA's collegiate body to appreciate and decide on the possibility of renewal for another 12-month period.

2. APPLICATIONS

2.1 The application period is from March 7, 2019 to March 18, 2019 and the required documentation must be forwarded to the Office of the Vice-president for Research and Graduate Studies - PROPPG, in person or via post office (Correios' express document shipping service - SEDEX with acknowledgement of receipt). In this case, the deadline for receipt of documentation will also be considered March 3, 2019. PROPPG will not be responsible for documents received after the deadline (pay attention to Correios shipping time). In order to hand over the required documents, it is highlighted that PROPPG opening hours are Monday to Friday 08:00 a.m. - 11:00 a.m. and from 01:30 p.m. to 05:00 p.m., except on official holidays. The following documents are required:

2.2 Application form duly completed and signed by the applicant (available in ANNEX II).

2.3 Documentation required

- a) Certified photocopy of the doctoral degree or equivalent document. If the degree has been granted by a non-Brazilian Higher Education Institution, the evaluation will be carried out by PPGCA's collegiate body. It is ensured the application of a doctoral

student or candidate who, besides not holding the required degree at the time of application, proves the ability to obtain it as the scholarship is granted. In this case, the applicant must inform and prove this condition at the time of application.

b) Photocopy of the academic transcripts of undergraduate, master's and doctoral degrees;

c) updated ID-sized photograph;

d) Certified photocopy of the certificate of electoral discharge, the official ID card, the Individual Taxpayer Registration Card (CPF, acronym in Portuguese) and, in the case of male applicant, proof of discharge with the military service;

e) An official statement with the authorization of the immediate superior to carry out graduate studies in case of approval, for applicants with employment relationship.

Obs.1: Upon presentation of the source application documents, the PROPPG officer will certify the photocopied documents received.

Obs.3: The applications will be appreciated and, if applicable, accepted by the Selection Committee and published by PROPPG as of March 20, 2019; the deadline for applicants to file an appeal against the result of accepted applications will be two working days from the publication of the result.

3. THE SELECTION PROCEDURE

3.1 The selection procedure is composed of the applicant's curriculum and proposal analyses:

- a) Analysis of Curriculum vitae on CNPq Lattes platform. The printed photocopy of the Curriculum vitae, prepared via CNPq Lattes Platform, the supporting documents and the completed score table, according to ANNEX III, should be handed over or forwarded to PROPPG at the time of application. The applicant with the highest score in the curriculum will be awarded score 10.0 (ten), which is the baseline for the proportional establishment of the other applicants' scores.

b) Proposal (maximum of 10 pages, 1.5 spacing and Times New Roman 12 font): the merit of the proposal will be evaluated by the Selection Committee, which will score proposals from 0 (zero) to 10 (ten); the applicant with a score lower than 7.0 (seven) in this stage will be unclassified. The Proposal must be handed over or forwarded to PROPPG in three printed copies, at the time of application, and it should contain the following items:

- I. Title of the Proposal;
- II. Applicant's and intended supervisor's names;
- III. Introduction;
- IV. Theory review;
- V. General and specific objectives;
- VI. Methodology;
- VII. Expected results;
- VIII. Technical feasibility;
- IX. Schedule;
- X. References.

3.2 The applicant's final score will be calculated as an arithmetic average of the curriculum and proposal analyses scores;

3.3 The preliminary results will be published on the PROPPG website as of March 28, 2019. After the publication of the preliminary results, the applicants will have three working days to file an appeal to the coordination of the PPGCA. Then the final results will be published.

3.4 The approved applicant must have the scholarship granted as of April 2019, and must hand over the research project within 30 days after the scholarship is granted.
